## **MAGISTERIAL CHARTER 07 / 2020**

To all Dames and Knights, Brethren of
Our Sovereign Order of Saint John of Jerusalem
Knights of Malta
Federation of Autonomous Priories,
let it be known by the present letters that

We, José, by the Grace of God Hereditary Regent and Grand Chancellor of the Sovereign Order of Cyprus, Hereditary Grand Prior and Procurator General of the Grand Priory of the Most Holy Trinity of Villedieu and, by the Will of Our fellow Knights, Prince Grand Master and Head of State of Federation of Autonomous Priories of the Sovereign Order of Saint John of Jerusalem, also said of the Knights Hospitallers or of Malta, in virtue of the powers bestowed upon Us, namely the by the Articles nº 1 and nº 2 of Chapter III and of the Chapter VII of Our Constitutional Letter,

considering that the Hospitaller work is the historical mission of Our Sovereign Order and of our State;

considering that the tragic outbreak of the COVID-19 Pandemic has forced all Governments of the World to impose very strict and serious preventive and prophylactic measures to protect their population and also that the said outbreak will still be active during the near future until specific treatment and/or an effective Vaccine will be available to all, Our Sovereign Order and State through Our Femeraid International, as its operational Medical Institution, must surround itself with the best possible expertise who can ensure the highest standards of quality of the services rendered;

Having had all the above stated facts in consideration and by proposal of with Our Prime Minister and Lieutenant General, but also Vice President of Femeraid International, in accordance with the terms of Our Constitutional Letter and as CEO and President of the Board of Directors of Femeraid International,

We come to decree and We do decree:

ARTICLE 1. By the present Charter We create in Our Femeraid International the position of
